INTRODUCTION

Hazchemwize (Pty) Ltd is committed to protecting your privacy. You can visit most pages on our site without giving us any Information about yourself. But sometimes we do need Information to provide services that you request, and this Privacy Statement explains data collection and use in those situations.

COLLECTION OF YOUR PERSONAL INFORMATION

We will ask you when we need Information that personally identifies you (Personal Information) or allows us to contact you. Generally, this Information is requested when:

Personal Information collected by Hazchemwize (Pty) Ltd is often limited to e-mail address, name, telephone number, location, but may include other Information when needed to provide a service you requested.

Server Side Logs / Analytics

For our web server to function properly, the following log data is required

Log Type	Retention Period
Access Logs	24 Hours
Error Logs	100MB
Security Audit Logs	10 days

These log files contain

- 1. Your IP Address
- 2. Your User Agent (Which describes your browser and Operating System)
- 3. The resources you request from the server
- 4. Date and Time of the request
- 5. Referrer (How you were directed to our site)

This data usually cannot identify a person, however when combined with other data it can possibly lead to the identification of a person. Therefore we treat this data as Personal Information and secure it appropriately.

Only authorized people have access to this data and the data is required for legitimate purpose of security and providing the service to you.

The log data is purged when it is no longer required

See "Use of Your Personal Information" for how we may use this log data for security purposes.

An IP address is required for the web server to return the resources you request from it. If you wish to opt-out and/or hide your personal IP address, please use a VPN service.

Client Side Analytics

We use the following Client Side analytics:

• Google Analytics

This collects further information and metrics about how our users interact with our web site, so we can improve our website and service.

You are able to opt-out of this analytics via the Cookie Policy Prompt.

On publicly available webpages, this Information is anonymized and identified only by a unique number and cannot be linked to your personal information.

Use of Cookies

Cookies are text files with small amount of data. Cookies are sent to your browser from a web site and stored on your device.

There are different types of cookies, the main categories are:

1. Session Cookies

- 1. These are set by the website owner (These are also First Party Cookies)
- 2. These are temporary cookies that remain active only while you remain browsing the website for your current session, and will be removed when you close the website
- 3. Examples: These provide services such as remembering what items you have added to your shopping cart

2. First Party / Persistent / Permanent Cookies

- 1. These are set by the website owner
- 2. However, unlike Session Cookies, these Cookies remain on the device beyond the active session
- 3. They should not be a requirement, but legitimate use should provide enhanced usability and convenience
- 4. They are created with an expiration date, which can vary with the Cookie but according to most privacy laws they should not exceed 12 months
- 5. Examples: Persisting authentication and site preferences across multiple sessions
- 6. User should be able to opt-out of these cookies

3. Third Party / Marketing Cookies

- 1. These are not set by the website owner
- 2. These are set by embedding components from a 3rd party (such as advertisements, chat service, social media, video)
- 3. These are the Cookies causing the most privacy concerns as they can be used to track a users habits, behaviors, interests
- 4. Examples: Advertisers can use these to provide targeted ads

4. Analytics Cookies

- 1. Generally set by Analytics software (these are also Third Party Cookies)
- 2. Should not personally identify users
- 3. They provide the website owner with metrics on how the website is being used and its performance, allowing the website owner to improve the website and service it provides
- 4. Example: Google Analytics
- 5. User should be able to opt-out of these Cookies

5. Malicious Cookies

- 1. These should not be set by the website owner
- 2. They remain or are recreated on the device after Cookies have been cleared

Hazchemwize (Pty) Ltd uses the following Cookies:

- Session cookies for authentication
- First party cookies for cookie consent
- First party cookies for authentication
- First party cookies for website preferences
- Anonymised Google Analytics Cookies
- Third Party Google Ads Cookies
- Third Party Facebook Ads Cookies
- Third Party YouTube Cookies
- Third Party Cookies for a Chat Widget

You are also able to anytime remove Cookies from your device, by clearing your Browser Cookies.

If you opt-out or choose to not have your browser accept cookies from Hazchemwize (Pty) Ltd, you will be able to view our website, however you might experience limited functionality nor will you be able to subscribe to the service offerings on the site.

USE OF YOUR PERSONAL INFORMATION

Hazchemwize (Pty) Ltd uses your Personal Information for the following purposes:

- To improve our website, performance and service to you.
- To ensure our website is relevant to your needs.
- Determining which products or services attract the most visitors.
- To provide required communication.
- To provide requested financial services.
- To deliver services, such as (products, newsletters, events, training or software), that you request or purchase.
- To help us create and publish content most relevant to you.
- To alert you to product upgrades, special offers, updated Information and other new services, if you so request.
- To allow you access to limited-entry areas of our site as appropriate.
- Determining which times our website receives the most traffic.
- · Using referral data to measure effectiveness of online advertising campaigns and search engine marketing.
- Learning more about customer base with device, browser, and geolocation data, and marketing to incoming customers according to their location.
- · Determining lost sales opportunities
- Examining error data to analyze and improve website performance and interface.
- Using page request data and time spent on different pages to find out which parts of your site are most successful and attracting/keeping the attention of visitors.
- Measuring the effectiveness of online advertising campaigns and search engine marketing.
- Learning more about our customer base with device, browser, and geolocation data, so we can provide a better service and market more efficiently.

For security purposes, the log data works as a forensic trail if our website is breached, hacked, or misused in any way.

Here are some ways that log data can be used for security purposes:

- 1. To determine the date, time, and location of a breach
- 2. To ascertain the identity of a hacker or offender
- 3. To prevent access to our systems of such a hacker or offender
- 4. To identify weaknesses in security and protection measures
- 5. To monitor security and create alert systems in the event of any unauthorized intrusion

Third Party Service Providers

Hazchemwize (Pty) Ltd may hire other companies to provide limited services on our behalf,

- Courier service
- Marketing Company
- Call Center
- Event Organisers

Hazchemwize (Pty) Ltd will only provide those companies the Information they need to deliver the service, and they are prohibited from using that Information for any other purpose.

Hazchemwize (Pty) Ltd may disclose your Personal Information if required to do so by law or in the good-Faith belief that such action is necessary to:

- 1. conform to the edicts of the law or comply with legal process served on Hazchemwize (Pty) Ltd or the site;
- 2. protect and defend the rights or property of Hazchemwize (Pty) Ltd and its family of Websites; or
- 3. act in urgent circumstances to protect the personal safety of Hazchemwize (Pty) Ltd employees, users of our products or services, or members of the Public.

CONTROL AND SECURITY OF YOUR PERSONAL INFORMATION

When you register, or otherwise give us Personal Information, Hazchemwize (Pty) Ltd will not share that Information with third parties without your permission, other than for the limited exceptions already listed above.

You will not be able to choose to unsubscribe to these mailings, as they are considered an essential part of the service you have chosen.

Hazchemwize (Pty) Ltd is committed to protecting the security of your Personal Information. We use a variety of security technologies and procedures to help protect your Personal Information from unauthorised access, use or disclosure.

ACCESS TO YOUR PERSONAL INFORMATION

We will provide you with the means to ensure that your Personal Information is correct and current, and to determine what Personal Information Hazchemwize (Pty) Ltd has of yours.

You can contact Hazchemwize (Pty) Ltd or our Information Officer for further assistance, if required.

If you register on SimonCompany or subscribe to a newsletter, you can review and edit your Personal Information at the Profile/Account page. You will be asked to authenticate before viewing your Personal Information.

You can:

- On your Profile, you can view and edit the Personal Information you have already given us.
- On your Profile, you can tell us whether you want us to send you marketing Information
- From our Newsletters, you can unsubscribe or opt-out of receiving further similar correspondence
- Request/update Your personal Information
- On your profile you can access the Information Regulator Forms to Request, Update or Destroy your Personal Information with Hazchemwize (Pty) Ltd

OPT-OUT PROCEDURE
